Consequent upon publication of the notification of the Prevention of Cruelty to Animals (Dog Breeding & Marketing) Rules, 2017 by the Ministry of Environment, Forest and Climate Change, Govt. of India vide Notification No. G.S.R. 496(E), Dt.23.05.2017, the said rules are hereby implemented in the State of Odisha with immediate effect.

As per provisions under rule-3 of the said rules, all Dog Breeding and Marketing establishments of the state are hereby required to obtain the Certificate of Registration from the State Animal Welfare Board, Odisha within a period of sixty days from the date of issue of this notification.
