On the recommendation of the Odisha Public Service Commission, Cuttack, the following 19 (Nineteen) candidates are appointed as Veterinary Assistant Surgeon (VAS) / Additional Veterinary Assistant Surgeon (AVAS) in Odisha Veterinary Service (Group-B) in the scale of pay of ₹44,900/— in the Level-10 of Cell-1 of Pay Matrix under the Odisha Revised Scale of Pay Rules, 2017 with D. A. and other allowances as admissible from time to time by the Government. They will be posted to the places on exercising their choice of place of posting on the date of counselling. They shall remain on probation for a period of two years from the date of joining in the post. Their services are subject to the following terms and conditions as per Service Rules.

- 1. The appointments are purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
- 2. The appointee should join at the place of posting within 30 (thirty) days with effect from the date of exercising of their choice of place of posting failing which, his/her appointment shall be automatically cancelled.
- 3. The appointee shall produce his / her Medical Fitness Certificate issued by a Medical Officer not below the rank of Assistant Surgeon.
- The appointee shall produce their Caste Certificate issued by the competent authority if required at the time of joining.
- 5. The appointee shall produce No Objection Certificate / Relieve Order issued by their previous employer at the time of joining, if they are in service.
- 6. The appointee shall produce all original documents along with one set of copy of the same documents duly attested and a Photograph shall be produced at the time of joining to the concerned CDVO of the district for necessary verification and records.
- 7. The appointee shall produce Character Certificate issued by any two Gazetted Officers at the time of joining.

- 8. The appointee shall furnish a declaration at the time of his / her joining in the post that there is no criminal antecedent / case pending against him / her. In case, it is detected subsequently that there is a criminal antecedent/ case pending against him / her, he/ she will be liable for termination from Government service.
- 9. The period of probation shall count towards increment.
- 10. No T.A. / D.A. shall be allowed to join in the place of posting.
