3. He will arrange the washing of the utensil of the participants.

A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **JOINT DIRECTOR, ANIMAL DISEASE RESEARCH INSTITUTE, PHULNAKHARA, CUTTACK** (To be submitted along with the quotation) as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The quotationer to deposit copy of Adhara Card, GSTIN Regd. Certificate & valid PAN Card.
6. The security money will be forfeited in case of any irregularity in servicing of food basing on report the of the food committee and participants..
7. The payment as per the schedule rate will be paid after satisfactory completion of food supply in each batch through PFMS.
