

5. The firms should submit Income Tax returns for last three years.
6. The approved firm will deliver the items to the Nodal Officer, Animal Birth Control Programme, Saheednagar, Bhubaneswar premises on receipt of supply orders. The accepted price will be valid up to 31.03.2021.
