The intending parties are advised to inspect the above vehicle lying in the office of the CEO, OLRDS, OBPI Campus, Siripur, Bhubaneswar between 11.00 A.M to 4.00 P.M on any working days before submitting the tender. Each tender must accompany an earnest money deposit of Rs. 1000/- (Rupees one thousand) only in shape of Bank Draft of any Nationalized Bank in favour of Chief Executive Officer, OLRDS, Bhubaneswar payable at Bhubaneswar, which will be refunded to the unsuccessful tenderers. The EMD will be adjusted towards the auction price for successful bidder.

The tender should reach the undersigned by registered post/speed post or by hand on or before dated **05.08.2020 up to 2.00 P.M** at the latest and tenders received shall be opened by the Auction Sale Committee in the Chamber of the Chief Executive Officer, OLRDS on Dt. **05.08.2020 at 3.00 P.M** in the presence of the tendering agencies or their authorized representatives. 5. The highest tenderer, whose tender is accepted, shall deposit immediately **25% of the offered amount** then & there as initial deposit. He shall deposit the balance amount within **3 days** of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of


